Roles and Responsibilities of Anti Ragging Squad

- To make surprise checking in hostels and other places vulnerable to incidents and having the potential of ragging.
- To conduct on the spot enquiry into any incident of ragging & shall submit in writing such report to the Anti Ragging Committee for further action.
- Anti-Ragging Squad shall maintain the record in the register of the surprise visits.

Roles and Responsibilities of Anti Ragging Committee

- To ensure complete compliance with the provision of UGC regulation 2009 at the institute level.
- To monitor and oversee the performance of anti-ragging squad for prevention of ragging in the institution.
- To recommend appropriate action in case an incident of ragging is reported by Anti-Ragging Squad or by the student(s) of the institute and to further inform/ get approval of the Secretary, DSSP & DIPSER. The Secretary may like to review the case if he feels necessary in the interest of the institution.
- Hold regular Review Meetings with members of the Anti-Ragging Squad shall maintain the record in the register of the surprise visits.
- Anti-Ragging Committee shall maintain the record in the register of its activities.
